Government Arts and Commerce College, Khergam is a state-run college established on 28/10/1992. The College is affiliated to Veer Narmad South Gujarat University, Surat .The College receives an academic calendar from the University at the beginning of every academic year. The time table committee of the college prepares the time table for teaching all the subjects as per University guidelines. The Board of Studies of the concerned subject of Veer Narmad South Gujarat University, Surat, prepares the curriculum that will be followed by the affiliated colleges. Our college receives circulars, letters and email from time to time from the University regarding any changes in the curriculum. The Principal informs the concerned teachers about the changes and gives them a copy of the circular. The University and the College authorities are proactive in ensuring that the faculty understands the curriculum properly.

The heads of the departments instruct the faculty members to deliver the syllabus within a stipulated time. In case a faculty member is not able to complete the syllabus within the stipulated time, he/ she arranges extra classes for his/ her subject. The College conducts remedial classes for academically weak students in English and accountancy. The librarian and the teachers work together to ensure that the students have access to all the books prescribed by the University. The College ensures effective implementation of the curriculum through the following means: 1) teaching diary or teaching plan is regularly maintained by the faculty and evaluated by the Principal 2) presentations by students 3) submission of assignments 4) use of innovative teaching methods 5) MCQ tests 6) implimentation of plan-do-check-act (PDCA) method

#### Feedback Obtained

Alumni Feedback Alumni Association was formed from the former students to contribute to the development, advancement and guidance of the college. The institution get feedback of them on the basis of the questionnaire designed including the points such as educational environment of the college, the quality of the teachers knowledge, presentation and guidance, and the activities like sports, NSS, and cultural activities as well as library facilities, guidance and support from the administrative staff, Drinking water facility, cleanliness of classrooms and entire college campus and ethical values. The feedback received 81 very good, 18.5 good, 0.5 average and 0 for poor Teachers Feedback The institution collects teachers feedback to know what are the shortcomings and where is the scope of improvement to meet its vision and mission. A questionnaire was designed including points such as educational environment of the college, curriculum, the subject knowledge, content of the course, freedom to adopt new teaching techniques/ strategies, availability of recommended books in the college library, the ICT facilities, cleanliness of classrooms, toilet and the entire college campus, and ethical values. The consolidated feedback showed that 69.13 of the teachers found the institution very good, 24.78 good, 6.09 average and none found it poor Student's feedback The Student Council has formed with the purpose to continue extracurricular activities and the overall development of the students of the college. The questionnaire was designed including the points such as educational environment of the college, the quality of the teacher's knowledge, presentation and guidance, and the activities like sports, NSS, and cultural activities as well as library facilities, guidance and support from the administrative staff, Drinking water facility, cleanliness of classrooms and entire college campus and ethical values. The feedback received 64.21 very good, 32.29 good, 2.90 average and 0.6 for poor (All numbers are in percentage.)

On 18th December 2019, each class at Khergam college attended a meeting under the chairmanship of the principal. In all 446 students participated in the meetings. Students had the opportunity to communicate to the principal various issues they were facing, including social, financial, health and language-related issues. The college conducted seminars and camps to help the students deal with their issues. For example, like health, Celebration of World Yoga Day on 21/06/2019, a seminar on de-addiction on 09/08/2019 by retired teachers Shri Lalubhai Patel and Chandravadanbhai, Seminar on "Women's Menstrual Problems and Cervical Cancer" was organized on 14/12/2019, Seminar on "Stress Management and Time Management" was organized on 08/02/2020. Seminars and camps are organized to provide employment opportunities to the students. For example, A lecture was delivered by Mr. Vashi Saheb, Managing Director of Vasudhara Dairy, on 18/07/2019, Under the "Youth Cooperative Training Camp" from 15/07/2019 to 20/07/2019, a Seminar on Stitching Training under Uddisha Placement on 28/08/2019, a seminar on Mobile Banking, Digital India on 05/10/2019, a lecture on Positive Attitude, Interpersonal Skill and Interview on 12/12/2019, On 17/12/2019 on Tuesday GST and Career Guides Seminar, 'Campus Placement Fair' was organized on 05/02/2020, as well as 44 students participated in S.B. Garda Arts P.K. Patel College of Commerce, Navsari in 'Job Placement Fair on Friday 14/02/2020. The students participated in the Womens Legal Awareness Camp at Dinkar Bhavan, Majigam on 12/08/2019. Remedial Classes were organized with the aim to improve English language along with Hindi and Gujrati under the guidance of Prof. Nishaben Chavada from A.V. Patel Commerce College, Billimora and Prof. Yogeshbhai Parmar from M.R. Desai Arts Commerce College Chikhali for the subject of Accountancy from 03/02/2020 to 05/02/2020. Jheel Shukla provided the training to the students for the first phase of the Finishing School training from 19/08/2019 to 23/08/2019, and the second phase of the Finishing School training from 08/09/2019 to 12/09/2019 and Haritaben Patel from Ahmedabad was present for third phase of the training of the finishing school from 25/12/2019 to 31/12/2019, and the fourth phase from 03/02/2020 to 07/02/2020.

2.5.2 – Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

Government Arts and Commerce College, Khergam, attempts to make effective use of the continuous evaluation system for the nurturing and guidance of students. The College takes every opportunity for early identification of any learning challenges faced by the students so that we can provide necessary assistance in the form of counselling, guidance, remedial classes or one-to-one coaching with the intention to let every student get the opportunity to thrive in the college environment. Assessments are not only confined to academics. The teachers have the chance to rate the students on many aspects such as their attendance in classes, behaviour towards the teachers and their peers, effective use of college facilities, participation in co-curricular activities and the like. This is aimed at encouraging the overall growth of the students as learners as well as individuals. It's our belief that although not all assessments, competitions and tests conducted by the college directly result in a score or point in the degree certificate or mark lists the students leave the college with, each effort at teaching, testing, assessing (based on the tests), guidance and assistance, and further chances at proving the skills and abilities of students, contributes towards their performances in the university prescribed examinations, and activities that result in the awarding of medals and certificates. From the time the students are admitted into the college, the college administration and the faculty work together to provide the students with an environment and system that allows step-by-step progression and guided flourishing of all their talents. To this end, teachers regularly conduct class tests, pop quiz, debates, and group discussions and the students have the opportunity to meet their teachers during office hours. Students who seem to be falling back in academics are offered remedial classes or extra classes to help them catch up and make the best of the university curriculum. However there are certain forms of assessment that directly reflect on the end-semester mark lists. This includes, 5 marks for attendance above 80, a maximum of 10 marks for their performance in the mid-semester internal examination, and 5 marks for timely and good quality assignment submission. NSS, Saptadhara, Udisa, and RUSA are some of the co-curricular and extra-curricular activities that facilitate the students development of and acknowledge their achievements in, various

talents and skills in the fields of arts, sports, debates, arts, social service etc. Finishing school is a new initiative by the college to enhance the life skills, employability, and English language skills of students through a 100 hrs. training categorized into four components.

2.5.3 – Academic calendar prepared and adhered for conduct of Examination and other related matters (250 words)

For External Examination the University decides the exam schedule and the results. So far as college activities and exams are concerned, college follows the academic calendar provided by the University and makes some modifications, if needed. And the same is communicated to the students. The institution adheres to the academic calendar for the conduct of CIE, prepared and provided by the University. This academic calendar is made available to the Heads of all the departments. The heads of all the departments in consultation with other teachers prepare their schedule accordingly. Similarly, the conveners of all the committees are also instructed by the principal to plan and follow the various activities such as Saptdhara, Cultural, NSS and Sandhan according to the plan provided by the University. Besides, UGC, KCG Ahmedabad and the Department of Higher Education, Government of Gujarat are also followed in terms of Choice Based Credit System (CBCS), Vocationalization of Higher Education such as Finishing School has now become integral part of the academic activity in the college. The Internal Exams are scheduled according to the schedule, framed and directed by the University. Academic sessions in the first term and the 2nd term commence promptly along with the admission work so that the entire syllabi can be covered well before the Internal Exams in the interest of the students.

The college is a government institution. All the facilities of the college

are provided by the Government of Gujarat. The construction, maintenance, repair, etc. of the building is done by PWD. The Principal of the College proposes to the Higher Education Department of the Government of Gujarat as per the requirement regarding construction, repair and by the Government, which allows the work to be done by PWD. IQAC committee has been formed at college level which suggests appropriate recommendations and plans for the colleges academic and physical use. Various committees have been formed to assist IQAC such as Library Committee, Gymkhana Committee, OBC Cell, Minority Cell, Internal Complaint Cell, Saptadhara Committee, Cultural Committee, Discipline Committee etc. The college has a sufficient number of class rooms. Purchase of benches for students to sit in the classroom is provided by KCG Gujarat Government. Classrooms are used for lectures and other educational activities such as group discussions, presentations, seminars and workshops. Classrooms are regularly cleaned by cleaning staff. Heads of Department maintain academic documents such as Departmental Master Time Table, Copy of Personal Teachers Time Table, Classroom Time Table, Internal Examination, Copy of Exam Time Table, Parents Student feedback reports etc. A list of the equipment required for sports is prepared and quotations are requested to purchase the equipments and the details of the equipment purchased are recorded in the dead stock register. Students are allowed to make maximum use of it for sport and practice. Physical training instructor is given the freedom to decide the time slot for the respective sports practice. The college has grounds for Kabaddi, Khokho, Cricket, Basketball and Foot Ball as well as good facilities for indoor sports like chess, carom, table tennis, etc. Recommendations for books / magazines are requested from the teachers for purchase of library books, magazines etc. and the prepared list sent to the principal for approval. And with the approval of the Principal, the vendors asked to send the price list of books. Purchased books are registered in the book registration register. Students and staff are encouraged to make maximum use of library resources. Books are provided to students and professors as needed. Daily visitors register is maintained by the librarian for Students and teachers. First-year students are oriented to make the library easier to use. Library conducts the Orientation program for first year students to use of library. If a book taken by students is lost or damaged, a new book is taken from the student. Books are returned by each student at the end of the semester. Students and staff are given a user ID and password to access subscribed e-books, e-journals and databases. They can access the subscribed resources from the library, college campus or remote area. The link to the e-resource is provided on the library page of the college website. The computers are purchased for computer lab by the Knowledge Consortium of Gujarat. Students and staff can use it by making entry in a lab register to use a computer lab.

Government Arts and Commerce College Khergam has initiated the following works based on the recommendations of NAAC peer team for quality enhancement of the institution In relation to the recommendation of commencing job oriented

programmes and start career counseling, the institution has requested to Knowledge Consortium of Gujarat for a 'Tally Beginners Course' to enhance employability skills in students under RUSA component-12, Vocational of Higher Education. The institution also tried to start UPSC/GPSC coaching classes for tribal students and a coaching centre is allotted to college on 04/09/2019. Meanwhile the college came to know that the agency which has got contract of coaching has dubious track record with evidences and the IQAC has cancelled the work order of the agency. As per the recommendation related to introduce science stream programmes at graduate level, the institution has been in correspondence with the education department of Gujarat to start science stream in the college since 2013. The commissioner of higher education, Gujarat has sanctioned science stream at graduation level in the institution from the academic year 2020-21. At first the institution received a letter of permission to start science stream on 23/06/2020 but due to covid -19 pandemic as well as the scarcity of grant the education department adjourned it to effect for the academic year 2020-21. With reference to the recommendation of permanent principal to be appointed, the education department of Gujarat has appointed the permanent principal in the college on 18/08/2020

### 7.2 – Best Practices

#### 7.2.1 – Describe at least two institutional best practices

In order to prevent students from dropping out of college, it is imperative
---

that these students get proper transport facilities. Thus, a separate government bus facility from the nearby town of Khergam to the college was started through intensive efforts, correspondence and face-to-face meetings with concerned office of Gujarat State Road Transport Corporation. The college requested The Manager, S.T. Depot, Valsad vide letter No. GACC/820/2019-20 dated 14/11/2019 to resume bus service from Dasera Tekri to Khergam College gate and issue bus pass to the students from the date of commencement of the second term. Further efforts have been made by the college/ Principal vide letter No. GACC/910/2019 dated 17/12/2019 to provide the request bus stop at the college gate which is been accepted by the regional director of S.T. Depot Valsad. The students can reach the college on time and can attend the college regularly. The above facility/practice has helped to make the attendance of students in the college more regular. The Finishing School was started by the Education Department of the Government of Gujarat with the intention of developing soft skills in the students and enabling them to build their livelihood on the basis of their skills in their academic careers. The college organized first phase of Finishing School training from 19/08/2019 to 23/08/2019, and the second phase of the Finishing School training from 09/09/2019 to 13/09/2019. The third phase training was organized from 26/12/2019 to 31/12/2019, and the fourth phase from 27/01/2020 to 31/01/2020. In the first phase of this training program, training was given on basic skills like life skills, negotiation skills, critical thinking, stress management, problem solving decision making, which resulted in self-awareness, self-esteem, self-confidence, life-goal setting, team work, self-discipline, commitment, observation Concentration skills, empathy, and interpersonal skills. In addition, in the second phase of the finishing school, students were trained on Employability, including Grooming and Personal Hygiene, Body Language, Resume Writing, Group Discussions, Presentation skills, letter writing, interview skills, punctuality, planning and organizational skills, Professional ethics, efficiency, Includes skills associated with the development of students ability to gain employment. In the tribal students or in their families, the skills required to grab such employment opportunities are not directly involved, so it is important to develop such skills and enable themselves for the employment opportunities available. In the third and fourth phase, students were trained on Functional and Spoken English. Students from tribal areas in particular have grown up in an environment where they cannot communicate fluently even in their mother tongue, so Functional and Spoken English skills are essential to connect them with current trends. Jhill Shukla was present as the resource person for first and second phase of training as well as Harita Patel for third and fourth phase which was attended by a total of 41 students. Thus, the institute is working to connect these students and their families as the mainstream of society and development by fulfilling the missing skills to connect the tribal area students with the mainstream of society through such training programs. With the intention of increasing the contribution of the students in the field of sports the institute constantly provides guidance and practice. As a result of which the students of the college have procured special achievements by participating in the Khel Mahakumbh organized by the Gujarat government. In which total of 24 students participated in the shooting ball competition and got third position with Rs. 9000 cash prizes, while 12 students participated in the kabaddi competition in which they achieved third place and received a cash prize of Rs. 9000. 2 students participated in the athletics competition in which Pawar Sulemanbhai won in 400 meter running and received a cash prize of Rs.5000. Remedial classes in accountancy subject under Rusa Component-06 were conducted in the college with the intention to bridge the gap in the subject and provide more practice as well as in-depth understanding of the subject matter from 03/02/2020 to 15/02/2020. As a result of which the interest in the subject of accountancy has increased among the students, as well as the students have become more proficient in the subject of accountancy. The institution organizes free health

check-ups for the newly admitted students in different disciplines at the college, for which a team of locally available and well-qualified doctors has been appointed by the institute, besides inviting the health team from the district headquarters from time to time. During the year 2017-20, total of 86 newly admitted students were examined by the medical team and appropriate advice and guidance was given by the doctors for the students who were not in good health, as well as what the students should take care to maintain their health. It was suggested that the students suffering from serious illness should be sent to the nearest public health center for further treatment. This type of health check-up system allows students from rural and remote areas to be diagnosed in the beginning if they have a serious illness and students become more aware of their own health, as well as the efficiency of the students is markedly increased after treatment. The annual camp of NSS is organized in one of the backward villages. In the academic year 2019-20, the camp was organized in the village Godthal from 02/01/2020 to 08/01/2020, where the NSS programme officers and volunteers organized distribution of sweaters, sleepers for men, children and women from very poor families with a joint venture of Shrimad Rajchandra Mission-Dharampur. For which two donors Ambarishaben Anilbhai Vora and Manjulaben Veljibhai Gada gave a grant in the form of 59 sweaters, 59 pairs of slippers as well as Rs. 10,500 in cash for the village where the children were given a group meal. The distribution of these donations, search for donors for donations, and search for suitable beneficiaries etc., as well as arrangements for childrens group meals were arranged by the students of NSS of this institute. Thus, students develop qualities for social service and get training of what projects can be undertaken for social service. Through the continuous efforts of the institute, in coordination with the office of the Commissioner of Sports and Youth Cultural Activities, Gandhinagar, a taluka level gym center has been inaugurated in the college from the year 2019-20. The Gym Center has set a very nominal fee rate considering the economic situation of the people in the area. It has also been decided to give a discount to the students of this college. The gym center is helping a lot in maintaining the health of the people in the surrounding area. The students of this college can also take advantage of it and achieve their best position in sports at taluka, district, state and national level. The facility of gym center is very useful for the youth of the surrounding area as well as college students and students studying in hostels to prepare for the physical test to be recruited in the defense force as well as the security forces. A student of the college Jay Patel has been selected in the pre-Republic Day Parade as well as State Republic Day under the guidance of the principal and N.S.S. programme officers. A student has got an opportunity to learn more about the new dimensions of Gujarats cultural and social life through interactions with students from different parts of Gujarat.
